#### **AGENDA ITEMS:**

- 1. Welcome & Self Introductions. The meeting was called to order by Ms. Daigle at 8:00 a.m.
- 2. The **minutes** from February 2012 were approved with amendments.

#### 3. Current Business:

- a. **Settlement Agreement Extension Update.** Kiff noted that, with several meetings complete, negotiations were "progressing positively."
- b. **JWA Operational Updates.** Eric Freed noted that WestJet would start service near the end of April 2012, and that United was planning on offering new Honolulu flights. He discussed the bid award for a landscaping project along Bristol Street, and that the County anticipated a bid award date of August 2012 for that project. Committee members briefly discussed the previous Saturday's overflight of military planes flying the "missing man" formation for a local veteran's funeral. Freed noted that JWA had no advanced notice of that flight.
- c. **Edwards' Monthly Report.** Tom Edwards summarized his March 2012 Monthly Report (please review it directly for more detail), including:
  - How Class A flights typically increase in April through October there are 85 Class A ADDs approved in the Settlement Agreement, with an option to fly 2 more flights if the 4 cargo flights are not being used.
  - Noise. The noise reports show a relatively consistent pattern with slightly less noise since 2008 the loudest flights today were the quietest ones years ago.
  - Of the revenue that JWA receives, 63% of it comes not from airplanes but from concessions, parking, and other ancillary uses.
- d. **Ontario Airport.** The Committee voted to recommend that the City Council send a letter to the City of Ontario, CA, supportive of Ontario's efforts to administer Ontario International.
- 4. **Public Comments on Non-Agenda items** involved further discussion of the STREL departure procedure and its "west of Las Vegas, northerly flight" cousin, the RAWLZ.
- 5. **The Committee's next meeting** was set for Monday, April 30<sup>th</sup>, 2012 at 8:00 a.m. in the Central Library's Friends Room.
- 6. The meeting was adjourned at about 8:34 a.m.
