

# **General Aviation Improvement Program**



### JWA General Aviation (2016)

192,800 annual operations

43.44 daily jet departures / 49.75 3Q 2018

482 based aircraft (capacity is 596)

# City Council Supports Alternative 3

- **Compliance with FAA:** Updates JWA's GA facilities and brings them into compliance with FAA standards
- **No Expansion:** Doesn't expand GA facilities or significantly alter the GA aircraft mix
- Fewer Operations: Results in the least amount of GA jet operations by 2026

# Our Issues with Project and Alternative 1

- More Jets: Increases GA jet traffic over Newport Beach and other communities.
- More Commercial Operations:
  - Introduces more commercial operations into the GA sphere of influence; and
  - Promotes commercial operations at privately held FBOs.
- International Travel: Encourages international travel to and from JWA.
- Safety and Security: Raises safety and security concerns related to allowing GA passenger screening at the private FBOs

#### GAIP and the Environmental Review Process

# What is the purpose of CEQA?

• Informational Document: Primary purpose of CEQA is to inform decision-makers and the public of potential environmental effects of a project.

• **Mitigation Measures:** The process should identify ways to avoid environmental impacts through implementation of feasible mitigation measures or alternatives.

# Program EIR and the GAIP

- **GAIP:** County drafted a Programmatic (or Program) EIR.
- **Program EIR:** Designed for large projects so the whole project (including cumulative impacts) can be analyzed and program wide mitigation measures adopted.
- **Subsequent Activities:** Specific projects may need additional environmental analysis if the specific activity was not fully analyzed in the Program EIR.

# Where are We in the CEQA process?

- **Draft EIR:** County prepared a draft program EIR and made available to public.
- **City Comments on DEIR:** City submitted comments such as:
  - Noise Analysis: Noise analysis used overly optimistic assumptions.
  - Flight Patterns: Basis for existing and new flight patterns associated with the GAIP were not properly disclosed.
  - Sensitive Receptors: Impact on specific sensitive receptors (like schools, hospitals, or places of worship) were not properly disclosed.
  - Health Risks: The health risk analysis is insufficient because it did not properly analyze emissions associated with the GAIP.

# Where are We in the CEQA process?

- **Response to Comments:** County has now responded to comments which can be viewed at:
  - Newport Beach Central Library; or
  - www.ocair.com/gaip/deir627/responses-to-comments
- **Review of Responses:** The City and the public will review the response to comments to see if the responses are sufficient and whether the EIR should recirculated.

# When is Recirculation of EIR required?

- **Recirculation Required:** County would be required to recirculate if significant new information is added to the EIR.
  - New Information: Information can include changes in the project or environmental setting as well as additional data or other information.
  - **Significant:** New information is significant if the EIR is changed in a way that deprives the public of a meaningful opportunity to comment upon a substantial adverse environmental effect of the project or a feasible way to mitigate or avoid such an effect.
