Overall atmosphere of peace and beauty and the glorious selection of books. Please reconsider your animal policy. Many people are allergic to animals and only ADA service animals should be allowed by law. Recently a conundrum of "permits", "certs", "licenses" etc. have appeared which designate the animals as "service" animals. ADA clearly states that No mental condition (e.g. paranoia, agorophobia, etc) is a service animal condition. During a recent visit to your NB branch we observed a "service" animal with 'out of state' certs, sitting on top of a writing desk in the CD area. Needless to say, this poses a contamination issue for the next patron who used the desk. Please look up the definition of "service" animal. These are federal guidelines which allow the owner to register the animal and potentially utilize a tax deduction on their federal and state taxes. At this point, there is a potential the City/Library will be liable for dog bites, contamination, etc. from "non-service" animals who might urinate or otherwise cause issues to patrons. It certainly causes consternation among patrons who have allergies and/or own pets which they don't bring in on false pretences. Natalie Basmaciyan responded via email as follows: I spoke with the customer this morning regarding her customer comment card we received on 1/28/13. She was pleasant, conversant and well-versed in the ADA guidelines. Her main concern was that she had seen this particular dog urinate and defecate outside the building before being placed on the Popular library desk. She also stated that the dog had open sores and appeared physically unwell. She spoke with her general counsel at her place of employment, and was informed that the ADA guidelines were updated, unbeknownst to her. She and I reviewed the policies at length, including the right to use miniature horses as service animals. She realizes that we live in a "permissive society" and "how very difficult the ADA policies are now." She wishes the ADA would revise the policies, since people can purchase fake tags and service animal vests online which she has verified. She finished the call by saying, "Your library is the best part of Newport Beach," and "my family is an anonymous annual donor."
