**VII. CURRENT BUSINESS**

**A. Ocean Boulevard Vision Plan - Approve Staff Recommendations for City Council Consideration**

- A. Request City Council create a 3-member Ad Hoc Committee from the Parks Beaches and Recreation Commission (PB&R) to guide the concept development and final Plans, Specifications and Estimates (PS&E) for landscape and park improvements for the public areas along Ocean Boulevard in Corona del Mar between Poppy Ave. and Carnation Ave (Vision Plan).
- B. Present improvement recommendations to City Council, see Attachment A
- C. Request that City Council allocate \$60,000 for the preparation of Ocean Boulevard Vision Plan PS&E.
- D. Recommend the Ad-Hoc Committee, with City Staff assistance, secure a designer to conduct public workshops, develop concepts, prioritize improvements and prepare PS&E for construction. Design and Construction may be in phases.

**B. Special City Tree Removal and Replacement Request - 440 Santa Ana Avenue**

A Special City Swamp Mahogany (*Eucalyptus robusta*) Neighborhood Tree located at 440 Santa Ana Avenue has been evaluated by staff and the City's Consulting Arborist, Dudek Inc. and found to have a poor canopy structure. Staff recommends the PB&R Commission (PB&R) approve the Special City Neighborhood Tree removal request due to hazard mitigation concerns. If approved by PB&R, the City will not replace the Swamp Mahogany tree due to powerline interference and its close proximity to the home.

**C. Special City Tree Removal and Replacement Request - 301 Marguerite Avenue**

A Special City Canary Island Date Palm (*Phoenix canariensis*) Neighborhood Tree located at 301 Marguerite Avenue has been evaluated by staff and the City's Consulting Arborist, Dudek Inc., which determined the tree was rapidly declining. Staff recommends the PB&R Commission (PB&R) approve the Special City Neighborhood Tree removal request due to hazard mitigation concerns. If approved by PB&R, the City will replace the Canary Island Date Palm tree with a King Palm tree, which is the Designated Street Tree for Marguerite Avenue, per Council Policy G-6 (Maintenance and Planting of Parkway Trees).
