C. Special City Tree Removal and Replacement Request - Vista Del Sol Median

A Special Neighborhood City Kaffirboom Coral tree (*Erythrina caffra*) located on the Vista Del Sol median has been evaluated by staff and the City's Consulting Arborist, Dudek Inc. and found to have a significant amount of internal decay. Staff recommends the Parks, Beaches and Recreation (PB&R) Commission approve the Special City Tree removal request due to hazard mitigation concerns. If approved by PB&R, the City will install a 60-inch box replacement Coral tree.

D. Reforestation Request - 2206 Port Harwick Place (Continued from June 7, 2022)

Staff recommends the Parks, Beaches and Recreation (PB&R) Commission consider the reforestation request of three City Lemon-Scented Gum trees (*Corymbia citriodora*) located at 2206 Port Harwick Place¹ (and below 17 Monaco). This item was previously brought forward at the June 7, 2022 meeting, where PB&R continued the item, requesting the ability to physically evaluate the view encroachment from the applicant's residence. Six Commissioners visited the site and, the applicant, Mr. M. J. Knitter, has met the procedural requirements for reforestation established in City Council Policy G-1 (Retention, Removal and Maintenance of City Trees). If approved by PB&R, there will be one-for-one replacement trees, three 60-inch box Brisbane Box (*Lophostemon confertus*) installed at the applicant's cost.

E. Reforestation Request - 938 Sandcastle Drive

Staff recommends the Parks, Beaches & Recreation (PB&R) Commission consider the reforestation request of a City of Newport Beach (City) Magnolia tree (*Magnolia grandiflora*) located at 938 Sandcastle Drive. The applicant, Mario Marovic, has met the procedural requirements for reforestation established in City Council Policy G-1 (Retention, Removal and Maintenance of City Trees). If approved by PB&R, a one-for-one replacement tree, a 36-inch box Western Redbud (*Cercis occidentalis*) will be installed at the applicant's cost.
