

# **BENEFITS SUMMARY**

## **Newport Beach Employees LEAGUE (LEAGUE)**

Effective January 1, 2022 through December 31, 2025

This summary is for informational purposes only and is not binding. For a complete explanation of all benefits and compensation, benefit eligibility, and restrictions, refer to the current Memorandum of Understanding (MOU) and the Employee Policy Manual.

## **COMPENSATION**

Salary Adjustments: January 2022 – 1.0%

January 2023 - 3.0% January 2024 - 3.0% January 2025 - 3.0%

<u>FLSA Overtime</u>: Non-exempt employees earn overtime for actual work hours in excess of 40 in their defined FLSA workweek.

<u>Contract Overtime1</u>: Non-exempt employees are eligible for contract overtime. Holiday Pay (or Holiday to Flex Leave) and pre-scheduled Vacation/Flex Leave are included in the 40-hour calculation for contract overtime. No other paid leaves count towards the 40-hour calculation.

<u>Overtime Rate</u>: Both FLSA and Contract Overtime are paid at time and one half (1.5) and are calculated using the regular rate of pay, except Contract Overtime calculations do not include any funds associated with the Cafeteria Plan allowance (cash back, opt-out cash).

<u>Standby Pay:</u> Eligible members on a standby assignment shall receive \$8 per hour for each hour of such duty. E.g. An employee on standby assignment for 16 hours shall receive \$128.

<u>Call-Back Duty Pay:</u> A unit member called back to work after their normal shift has ended, and it is not prescheduled for overtime, will receive pay for actual hours worked, with a two-hour minimum payment.

<u>Compensatory Time Off:</u> Non-exempt members may receive Compensatory Time Off in lieu of cash for each overtime hour at the rate of one and one half (1.5) hours.

Night Shift Differential: Members assigned a work schedule which includes four or more hours worked between 5 PM - 5 AM shall receive \$1 (\$0.50 for automotive shop mechanics) per hour for every hour worked past 5 PM. E.g. Normal work schedule is Monday through Friday, 1 PM - 10 PM, employee, would be eligible for 5 hours of Night Shift Differential pay for all five days. This pay is not offered when working overtime beyond a normal work schedule.

<u>Certificate Pay:</u> Employees may be eligible for certificate pay for job-related certificates, up to a maximum of \$5,000 annually. For a complete listing of eligible certificates refer to the current MOU.

<u>One-Time Payment</u>: All bargaining unit employees in paid status for the entirety of the pay period following City Council adoption of this MOU shall receive a one-time payment of \$2,000.

<u>Safety Shoes</u>: Eligible employees receive an annual voucher for safety shoes. See current MOU for more information.

**<u>Uniform Allowance</u>**: Reported to PERS as \$95 per year.

#### LEAVES

<u>Flex Leave2</u>: Unit members shall accrue Flex Leave based on years of continued service at the following rates:

<u>Vacation<sup>2</sup> and Sick Leave</u>: Employees hired on or before January 1, 1990, who did not convert to the Flex Leave program, may accrue Vacaction and Sick Leave for time off of work. Those employees accrue Vacation and Sick Leave based on years of continued service at the following rates:

<u>Holidays</u>: There are 12 holidays observed per year, which include: New Year's Day, Martin Luther King Jr. Day, Washington's Birthday, Memorial Day, Independence Day, Labor Day, Veterans Day, Thanksgiving, Friday after Thanksgiving, Christmas Eve (½ day), Christmas, and New Year's Eve (½ day).

In addition to the holidays observed, unit members receive eight (8) hours for a "floating holiday" credited to their Flex Leave bank during the pay period which includes July 1.

<u>Bereavement Leave</u>: Forty (40) hours of paid leave for the necessary absence due to the death or terminal illness of an immediate family member. See MOU for list of qualifying family members.

<sup>2</sup>The City complies with the IRS Title 26 CFR § 1.451-2 Constructive Receipt of Income with regard to Flex Leave pay out.

## **BENEFITS**

<u>Cafeteria Plan:</u> Members participating in the City's medical plans receive a monthly cafeteria allowance of \$1,725 (plus the CalPERS medical premium contribution) to cover the costs of health premiums. If the cafeteria allowance exceeds the premium amounts, employees will receive the difference in taxable cash.

**Opt-out:** Eligible employees receive \$1,000 per month as taxable cash back.

<u>Life Insurance</u>: City paid policy up to \$50,000 in coverage based on annual salary.

**Disability Insurance:** City-paid benefit.

<u>Employee Assistance Program (EAP)</u>: The EAP provides confidential counseling, education and referral on work and life issues at no cost to the employee; subject to provider guidelines.

<u>Tuition Reimbursement</u>: Maximum tuition reimbursement is \$1,500 per fiscal year.

<u>Deferred Compensation (457 Plan)</u>: Effective December 21, 2019 (January 1, 2020), the City will match each member's active contribution, up to \$25 per month.

<u>Retirement Benefits</u>: The City contracts with the California Public Employees Retirement System (CalPERS) to provide retirement benefits and has implemented first, second and third tiers. CalPERS makes the final decision as to which tiered benefit an employee will receive.

Member Contributions: 13%

<u>Tier I (Legacy 2.5%@55)</u>: Members contribute 10.42% of the total net employee rate, which is 8 % employee rate and 2.42% employee rate modifier, and 2.58% towards the employer rate.

<u>Tier II (Classic 2%@60)</u>: Members contribute 7% of the total employee rate and 6% towards the employer rate.

<u>Tier III (PEPRA 2%@62)</u>: The minimum required member contribution for Tier III employees is subject to change based on the annual PERS valuation. The employee rate may increase or decrease as provided by CalPERS; the City adjusts the employee rate and adjusts the employer rate contribution so that the total member contribution aligns with Tiers I and II members.

## **RETIREE MEDICAL PLANS**

Retiree Health Benefits Program: The City participates in a Retiree Health Savings (RHS) defined contribution plan with contributions paid by both the City<sup>3</sup> and the employee. Employees hired prior to January 1, 2006, and whose age and years of services totaled 50 or more, were enrolled in either the fully-converted plan or hybrid plan. Employees hired on or after January 1, 2006 participate in the fully-converted plan. Please refer to the LEAGUE MOU for full details.
