A. Reforestation Request - 1215 Outrigger Drive

Staff recommends the Parks, Beaches & Recreation (PB&R) Commission consider the reforestation request of a City of Newport Beach (City) Carrotwood (*Cupaniopsis anacardioides*) tree located at 1215 Outrigger Drive due to root and seed pod concerns. The applicant, Amy Elliot, residing at 1215 Outrigger Drive, has provided the homeowner association board meeting minutes with their approval of her request, which is required for PB&R consideration. If approved by PB&R, there will be a one-for-one replacement with a 36-inch box Magnolia 'Little Gem' (*Magnolia grandiflora* 'Little Gem') tree installed at the applicant's cost.
