VI. <u>CURRENT BUSINESS</u>

A. Special Tree Replacement/Removal Request - 1700 Candlestick Lane, and 1700 and 1701 Starlight Circle (Special City Tree)

Staff recommends the Parks, Beaches and Recreation (PB&R) Commission approve the removal/replacement request of seven Special Neighborhood City Lemon-Scented Gum Eucalyptus (*Corymbia citriodora*) trees located at 1700 Candlestick Lane, and 1700 and 1701 Starlight Circle due to a combination of factors which place the trees at increased risk of whole tree failure.

This request complies with the provisions set forth in Section lof Council Policy G-1 (Retention, Removal and Maintenance of City Trees). If approved by the PB&R Commission, there will be a one-for-one replacement tree for each Special tree removed with a 36-inch box Ghost Gum Eucalyptus (*Corymbia aparrerinja*) installed in the same neighborhood location.
