D. Reforestation Request- 1932 Altura Drive (Front 1)

Staff recommends the Parks, Beaches and Recreation (PB&R) Commission consider the reforestation request of a tipu tree (*Tipuana tipu*) located at 1932 Altura Drive (Front 1) due to the tree outgrowing the parkway size and causing repeated infrastructure damage.

The applicant, Sylvia Burnett, residing at 1932 Altura Drive, has met the procedural requirements for reforestation established in City Council Policy G-1 - *Retention, Removal, and Maintenance of City Trees* (City Council Policy G-1). If approved by the PB&R Commission, two 36"-box 'Natchez' hybrid crape myrtle (*Lagerstroemia 'Natchez'*) replacement trees will be installed at the applicant's cost.
