- Set up will begin at 7:30 a.m. on Saturday, May 16, must be completed by 8:30 a.m.
 - Early set up for **Indoor vendors:** Friday, May 15, between 1-3:30 p.m.
- Electricity and any special accommodations (if applicable) must be arranged in advance, vendors must provide all other equipment related to exhibits. (including extension cords)
- The number of vendors for each industry is limited. OASIS staff has the sole discretion of selecting or rejecting applications.
- **No refunds will be given after April 17, 2026.**
- Misrepresentation of business or organization may result in removal from event.
- Number of sales cannot be guaranteed, nor can a certain number of attendees.
