## ABOUT THIS PROJECT

Exciting news! The underground civil work is completed and accepted by SCE, AT&T and Spectrum for your project area bounded by River Avenue, Neptune Avenue, 47<sup>th</sup> Street, 45<sup>th</sup> Street and Channel Road. System wiring by the three utility companies should begin shortly. In addition, the final water main replacement efforts for the remaining older pipelines in your area will begin in the next few weeks. Reconstruction of concrete alleys will occur after poles are removed.

Undergrounding along Balboa Boulevard encompassed by the Southern California Edison Rule 20A program has also been completed and accepted by the utility companies. This work was completed at no additional cost to property owners.

## WHAT'S NEXT FOR THE RESIDENTS?

SCE and Spectrum have already begun system wiring. AT&T should follow shortly, which will also include fiber upgrades to your area.

**It is now time to begin the residential conversion part of construction. You are invited to a virtual community meeting on August 12, 2020 at 4 PM. The City staff and utility companies will discuss the next steps in the undergrounding process. Join the GoToMeeting at:**
