NOP/IS Comments - City Hall & Park Master Plan

Jamie, I wanted to make just a couple of notes on the document that was posted for public review on the city hall and park master plan. First of all, each of the areas that are addressed in this document are important to study. I would like to comment on each area, but will leave that to others who have more experience in responding to these documents and will know how best to position concerns.

As a resident of Corona del Mar, there are several that will have a direct impact on this community, so I will limit my comments to just a couple of areas. They include:

- 1. Public view planes: You addressed view plane ("scenic vista") considerations along MacArthur and Avocado, but should also mention the significant view plane along San Miguel between Avocado and MacArthur. While MacArthur has the most predominant scenic vista given the course of the road and the number of vehicles and pedestrians that travel along it on a daily basis, consideration of the views from San Miguel should also be considered since it is at one of the high points of the designated parcels. I travel MacArthur Blvd each day, once in the morning and once in the evening, and have enjoyed these spectacular panoramic views whether at dawn or dusk. View plane preservation and light mitigation in this area are of significant concern. Must has been done in the initial stages of this project to address these concerns; we should continue to do so throughout the entire project.
- 2. Traffic: Without a doubt, Corona del Mar will be impacted greatly by the traffic flows generated at the new city hall. Not only will we be dealing with something in the neighborhood of 400-500 car trips a day for employees, but we will have the added traffic for deliveries, visitors, maintenance crews, etc. As you know, PCH through Corona del Mar more resembles a parking lot than a highway on any given day. This added traffic will have a tremendous adverse impact on residents. And given the narrow, almost impassable side streets throughout the village, alternatives to PCH through town are not really a viable option.
- 3. Project Scope: In the last several weeks, a dialog with city staff and city council has emerged regarding the location of the city's permanent Emergency Operations Center (EOC) within the new city hall. In reading through the project scope, there doesn't seem to be a mention of this. It may be because it is considered interior office utilization; however, if it needs to be called out separately (as is the meeting hall) we should do so now so that it is part of the impact study going forward. The scope currently reads:

"The proposed project would result in the relocation of City Hall (with the exception of the Fire Department).

- including all City employees and functions. The proposed project includes construction and operation of
- (1) an approximately 90,000-square-foot (sf) City Hall building, meeting hall, and Council Chambers:
- (2) a 450-space parking structure; (3) an approximately 20,000 sf expansion of the Newport Beach Central Library;
- and (4) construction of a public park. The proposed development areas/uses for the proposed project site are shown in Figure 2."

Thank you for the opportunity to provide comments. I will look forward to receiving additional information on this project as it becomes available.

I live in the neighborhood directly above the Newport Beach Central library overlooking the land where the city wants to build the new City Hall building.

Ever since the land was designated as the site of City Hall I have been worried that it would block my view and bring down the value of my neighborhood and home. If the city continues with its plans to build city hall on that parcel, it will be directly in my view of the ocean. Hi Dave.

Thank you for the heads up. This meeting also conflicts with a meeting at Beckman Auditorium on the Physics of Baseball - Why aluminum bats hit longer than wood. Why curve balls spin etc. etc.

If I could attend I would respectfully request serious consideration of the traffic flow around the existing plan, to wit: Virtually all of Corona del Mar and Newport Coast residents wanting to go to the proposed city hall from the North East must drive through San Miguel – MacArthur-

Avocado intersections, which are among the most congested in the city. Current designs have arbitrarily closed the option of extending Farallon or permitting entrance to the city hall parking structure from southbound MacArthur or an exit for southbound vehicles.

One need not rely upon traffic counts to see that this area is seriously flawed from a traffic circulation element. Current use, without the addition of an estimated 850 plus trips per day needs to be remediated, and alternative access to and from Macarthur to/from the parking structure would go a long way to solve this problem without the necessity for intersection modification, or signals. It would appear from preliminary designs that the grade of the parking structure roof is about the same as Macarthur. This becomes particularly important because of the supplemental construction planned for the Library and meeting hall at the city hall.

Serious thought should be given possibly to making Avocado one-way, or extending through traffic to San Joaquin Hills Road. I hope that expansion of San Miguel from Newport Center Drive to MacArthur is in the works.

Dave, I cannot attend. Could you either read this into the record or cause it to be filed so that particular attention can be given to this issue? By the way, dinosaurs are some of my grandchildren's best friends. Let's show a little respect.
