Reasons why project is exempt: Continuation of the Categorical Exclusion Order is statutorily exempt from CEQA, pursuant to Section 15265(a)(1) of the California Code of Regulations, Title 14, and Chapter 3 of the Coastal Act, because CEQA does not apply to a local government's preparation and adoption of a local costal program. Also, Development covered by E-77-5 has been determined by the California Coastal Commission to have no potential to create a significant adverse effect on coastal resources or on public access. Therefore, this project is covered by the general rule that the California Environmental Quality Act (CEQA) applies only to projects that have the potential for causing a significant effect on the environment (Section 15061.b.3 of the CEQA Guidelines). It can be seen with certainty that the reauthorization of the categorical exclusion order has no possibility to have a significant effect on the environment.
